## FOR YOUR INFORMATION ONLY-LPS ASKS TAXPAYERS FOR A MILL LEVY INCREASE

Question to be on November 2, 2010 ballot On July 29, 2010, the Littleton Public Schools Board of Education approved language for the item on the November 2, 2010 ballot that asks voters to approve a mill levy increase. The increase would generate \$12 million annually for LPS and would help future education cuts by the state from being as detrimental, beginning in school year 2011-2012.

Since 2008, the nation's economy has suffered and Colorado has been affected, as well. As a result of state funding cuts to K-12 public education (LPS receives about 60 percent of its funding from the state), LPS had to reduce its budget by about 10 percent, or \$14 million, in three years. Class sizes went up, fees increased, two schools were closed, programs were cut, about 200 jobs were cut, and school supply budgets rolled back to the level they were 20 years ago. The school year was shortened by two days to accommodate two furlough days for all employees. All students have been affected by these cuts.

It is projected that the state will require similar cuts again from K-12 education in 2011-2012 and beyond.

The Board of Education struggled with the idea of an election, but ultimately felt that it was necessary to move forward and let the community decide.

The mill levy increase would allow LPS to: Continue to provide academic excellence and an educational program of the highest quality and standards:

Maintain class size;

Provide a comprehensive education, including art, music, and P.E.;

Provide curriculum and instruction necessary for success in college, post-secondary education, and the workforce;

Maintain adequate numbers of well-qualified teachers:

Continue to provide students with a safe learning environment.

### LARGE ROLL-OFF CONTAINER

The container was another successful effort in keeping our neighborhood clean and looking good. Plus it saves you money. You filled another container to the brim with unwanted stuff. There are a few problems we confront every time we have one of the roll-offs in the neighborhood. It takes the entire Manor Board to clean up the mess and load the container correctly.

Please be considerate of the following requests.

Large Roll-Off Container, Continued

**First**: PLEASE load the container from the front to the back. If you dump your stuff next to the container's door, no one else can get in. If you can not open the door and walk in, please call one of the board members for assistance.

**Second**: PLEASE STACK your items in an orderly fashion. Break down tables, chairs, old cabinets etc. before you put them in the container. If you can not, please call me as I love to smash things. It relieves a lot of tension.

Third: If you drop something on the ground PLEASE PICK IT UP. We found boards on the ground with nails sticking out just waiting for someone to step on them and be hurt. Trash was left on the street with the expectation that someone else would clean it up. Bring a broom so you can clean up your mess.

Fourth: IF THE TRASH WILL FIT INTO YOUR REGULAR TRASH CAN - PUT IT THERE. Waste Management will take it. It is a waste of all of our money to put household trash into the roll-off that is to be used for large items.

A reminder for future reference – a metal recycling drive does not happen every time there is a roll-off. It will be clearly stated when we are picking up metal. Please keep your items for the next time we pick up metal.
