# PROTECT YOUR IDENTITY WHILE DONATING USED ELECTRONICS

#### (from Arapahoe County Sheriff's Office)

Spring is just around the corner. As we prepare to clean out our unused and unwanted items around our home, it is important to protect our personal information while doing so. Many households have computers and electronics that hold personal information that is very valuable to scam artists. Here are some tips to use when donating your personal computer:

Before donating or recycling your personal computer, you can avoid identity theft by erasing personal data and removing your files. Windows and Mac OS do not completely remove files you delete, but thirdparty software can.

Here are some other things to keep in mind:

- · Recycle old and broken hardware
- Contact the recycler or refurbisher before recycling as some offer free system erasing. Just download the program from <u>http://eraser.heidi.ie/</u> and follow the instructions on the Web site.
- Alternatively, you can take many PC's back to their factory fresh condition by using the restore CD that may have come with the machine.
- · Remember to include the accessories.
- To ensure that the software transfer is legal, pass along the original disks, media, Certificate of Authority Sticker (usually on the computer), user manual, and other documentation that came with the equipment.

If you find this process too cumbersome, contact a professional in your area to erase your computer or electronics. You may also find door-to-door pick up and recycling in your area by visiting earth911.com.

Reaching out as a Community – Columbine Manor Japan Relief Fund We all enjoy our wonderful, close-knit neighborhood. As we all know, "tis a privilege to live in Columbine Manor." It truly is! Many of you may be wondering what you can do to send help to Japan, as the story of mass destruction and suffering unfolds daily. Just imagine if our entire neighborhood was flattened, completely destroyed, in a few short hours. It is unimaginable! My name is Doreen Smith. I am one of your neighbors, at 5192 W. Fremont Dr. I have partnered with Hiroo Shiba to collect relief funds throughout our neighborhood. I believe that any amount at all that we can send to Japan will help. The need is so desperate for basic supplies - namely, food, water, warm clothing, blankets, medical supplies, and fuel. This monumental disaster is unfolding rapidly. The need for different types of supplies will become clearer in the near future. But now it is the critical time to reach out in a humanitarian effort to simply help save lives. We have selected two charities to choose from that we believe can deliver these basic supplies to survivors.

#### 1. American Red Cross 2. Save the Children

If you choose to donate to Red Cross, we will clearly specify your contributions go toward "Japan Relief". Otherwise, contributions would go to their general fund.

The Japanese Red Cross Society is working around the clock to provide food, water, blankets and portable heaters in shelters. They are airlifting survivors that need medical treatment to Ishinomaki Red Cross hospital in Myagi prefecture, near the areas that were hardest hit. There is concern that many patients who swallowed water and fuel from the tsunami may develop pneumonia. The elderly and young are particularly vulnerable to respiratory infection. The nights are bitter cold because there is no electricity in the shelters to provide heat. According to the organization called Save the Children, children are always among the most vulnerable during emergencies. They estimate that at least 100,000 children have been affected by the disaster. Tens of thousands of them have been evacuated. This organization is focusing on children and their families' immediate needs with psychosocial support to address the trauma, fear, and uncertainty many are experiencing. Relief experts are working non-stop in the disaster zone to assess children's needs and create safe play spaces for them within shelters. The first one has already been created in Sendai. Save the Children is also looking with a watchful eye toward the immediate future – they are creating contingency plans should the situation at the nuclear plants worsen. I have a personal connection to Japan – when I was in college I won a grant to visit Japan for six weeks, to draw landscapes. As an artist, I knew it would be a challenge, and a unique opportunity to immerse myself in the culture. I only had one year's worth of Japanese language skills. I had to be willing to make a fool of myself. I sure did when I replied, "ii desu neee!", which meant, "that's so great!", after an acquaintance told me he had just attended a funeral. (His suit and tie threw me – I thought he'd just come back from a really great party!) Luckily, my speaking and comprehension improved after that, and I was thrilled! We straightened out the funeral situation and had

a good laugh.

I stayed in a small town called Kakuda, in northeastern Japan, south of Sendai and all of the coastal towns that have been devastated by the tsunami. Its population at the time, in 1989, was around 40,000. I traveled all over the place on bicycle and spent my days outdoors drawing landscapes and taking pictures of the landscape, the town, and its people. This was a very rural area. I was lucky to find ancient Shinto shrines, old bus stops and houses, along with thoroughly modern homes and shops. I was welcomed so graciously into homes, and very well fed! It was the experience of a lifetime. I am so grateful to have met such wonderful people.

I am relieved to report that the tsunami largely missed Kakuda. All of the wonderful people I met are alive. But, I had visited Sendai several times and can only imagine the devastation there.

Times have been tough economically for us in America. There have been so many recent terrible natural disasters that have required relief funds. A large contribution is not the goal here. This is simply a chance to come together as a community to reach out as humanitarians. Something we can do together and be proud of helping. Believe me, Kakuda and the coastal towns of northern Japan are essentially Littleton, Colorado. They were filled with wonderful neighborhoods, grocery stores, restaurants, coffee shops, car dealerships, etc. The spirit of those people was warm and welcoming, just as it is here. Imagine all of Littleton destroyed in one single afternoon.
