It is springtime and many of us are outside enjoying the weather, walking through our neighborhood and exercising our dogs. Here is some information to help keep us safe.

Dog owners in Unincorporated Arapahoe County are required to have their dogs licensed annually. It's very quick and easy to be in compliance with the law by going to http://www.co.arapahoe.co.us/departments/pw/animalcontrol/licenserenewal.asp

From the Arapahoe County Ordinance - "Running at large" Or "Runs at large" means a dog that is upon public property, or upon the private property of a person other than the dog's Owner, Keeper or Possessor, when said dog is not under the Control of the dog's Owner, Keeper or Possessor; or a dog that is upon the private property of a person other than the dog's Owner, Keeper or Possessor, without permission from an owner of the private property or his/her agent, even if said dog is under Control of the dog's Owner, Keeper or Possessor. Dog owners can be cited by an Animal Control Officer when in violation of the Ordinance.

I learned this information after an incident on Saturday, March 17 when I had been walking my two leashed small dogs. While walking on the sidewalk on Hinsdale Circle, my dogs and I were attacked by three large dogs. The dogs were not leashed, nor were they under control of the owner/keeper/possessor. The dogs charged at us as they rushed from the driveway or garage. The large dogs were all over my small dogs and the leashes were pulled from my hands. My youngest dog was chased onto the yard across the street. The more aggressive dog of the three had her pinned down with it's mouth wide open on her. My dog escaped and ran home which was about a half mile. Fortunately my dogs and I were not harmed but were terrified by the attack. Thank you to the neighbors who helped us home.

My advice to others who may enjoy walking through the neighborhood, with or without dogs, is to be very watchful. Dog owners, please be responsible and keep your dogs under control at all times and license your dogs in accordance with the Arapahoe County Ordinance. We all have the right to be safe while walking in our neighborhood.
